1. Accepted at MasterCard merchants and as an ATM card through affiliated networks,
2. When you use the card in an ATM machine you will incur any fees and limits associated with that machine,
3. When you use the card in a First State Bank - ATM there will be no fee,
4. When using the card at other ATM machines a \$1.00 fee for each transaction from First State Bank will apply,
5. The card has a pre-set usage limit that will be set by First State Bank,
6. The daily availability of the pre-set limit is based on clearance of items purchased or funds withdrawn,
7. If the computer system is down the limit will be automatically reduced until the system is back on line,
8. The cardholder will receive a Personal Identification Number (PIN) for use at an ATM,
9. Approved transfers may not be posted to your account on the same day they are approved.
10. This agreement does not contemplate extensions of credit, open-end or otherwise, from us to you.
